Pastor's Comments

The Wednesday morning Bible class is beginning to work through the narrative of the Old Testament. So far, we have looked at the two opening chapters of the book of Genesis where it is clearly stated that God is the source of

all things that are created and that everything was created exactly as God intended it. Man and woman are also described as the high point of God's creation, intended to have a special relationship with God. In addition, God intended his creation to be one of total pace and harmony.

However, as we look at the description of God's creation in these chapters, it is also

apparent the picture of harmony in those opening two chapters of Genesis does not look anything at all like the reality of the world in which we live. (If you have any doubts listen to the news.) If we ask why the discrepancy, Genesis chapter three explains why, as it depicts the fall of mankind into sin and the effects of that rebellion, which was to bring total disharmony. Yet, even as mankind falls into sin, Genesis 3 includes a glimmer of hope. God is going to do something to fix it. Then, after giving that brief glimmer of hope, Genesis 4 through 11 describe how once sin entered, it was all downhill after that.

A major change in the narrative of Genesis comes with chapter 12, God's call of Abraham, as the Scriptures now begin to tell the story of the process of how God fixed the mess man had brought about with his fall into sin. It is a process that will involve Isaac, Jacob, the slavery of the nation Israel in Egypt, Moses and the Exodus, Joshua, and David. It is a process that took centuries until finally it culminates and is brought to completion in Jesus, God become flesh in order to take the sin of the world upon himself, so that all who confess him as Savior could be set free from the death brought on by sin and dwell with him eternally.

Through our faith in Jesus each one of us is the beneficiary. Our sins are forgiven. We possess that harmony God intended for his creation. Yes, it is also true that as long as we live in this fallen world we will be effected by it. We will not be immune to the same kind of accidents, sicknesses, and tragic deaths that plague humanity as a result of man's fall into sin. However, even as we live in this fallen and

sin distorted world, there is a huge difference, as Paul reminds us in Romans. None of this horrible stuff has the power to separate us from the love of God we have received in Christ Jesus. We already possess that one thing that matters, the forgiveness of our sins. Being forgiven assures us that we are God's family, and that our ultimate destination is that we will dwell with God forever in bliss and harmony.

So, amidst the trials and difficulties that we call life in this world, we live with a unique confidence. As a result of our faith in Jesus, our path will lead to and culminate in eternal life. It is sure, it is certain, because it does not depend on us, but on Jesus.

Congregational Self Study and Eventual Call Process

We have received the "Congregational Self Study" documents from the district. Portions will be filled in by the church office and by the elders. However, there is also a significant portion that the members of the congregation are invited to complete, which will then be tabulated and reported by the elders. The purpose is to enable us to identify what the members of the congregation see as the strengths and needs of St. Paul, as well as the characteristics that are considered desirable in the new pastor.

There are two pages that congregation members are invited to fill out, along with several pages of definitions to assist in filling out the one page. These papers for you to take home and fill out are available on the tables in the narthex. They must be returned by Sunday, September 27, after which they will be tabulated. The papers may be returned to the church on a Sunday or turned in to the church office.

The results will be tabulated and a report will be included in the October Newsletter, which should be ready to email by October 4. This October Newsletter will also include an invitation to the members of the congregation to submit names for individuals they desire to be considered as pastor of St. Paul. Again, forms will be available on the tables in the narthex. The deadline for returning these forms suggesting names of individuals to be considered for pastor will be Sunday, October 22.

This list of names will then be submitted to the district office, which will provide the Self Evaluation Tool (SET) and Personal Information Form (PIF) for each of the names submitted. In addition, the district president will add names, based on the Congregational Self Study, and his personal knowledge of the congregation. The names heads will be individuals he believes would be good for the congregation to also consider. Hopefully we would have this information by the end of November.

Once we have received all of the information from the district office, then the call committee will begin the process of evaluating the qualifications of those whose names were submitted and for whom we have received information. (It is possible that the district might not be able to have access to the information from every suggested individual.) According to the constitution of St. Paul, the call committee consists of the elders, the chairman and vice chairman of the congregation, the circuit visitor, and the vacancy pastor.

The call committee may decide to interview several of the individuals, and eventually it will propose a list of several recommended names that are considered to best meet the needs of St. Paul. These recommended names, along with the evaluation and qualifications of each will reported to the congregation three weeks prior to the voters' meeting at which the call will be issued. At that meeting, any voter may move to amend the list by adding the name of one of those individuals for whom we have received information from the district office. (New names will not be able to be added at that time.)

Beyond the October 22 deadline mentioned above, at this time no other specific dates can be given.

Initially the work center was housed at Concordia, Granite City. Now it occupies a couple closets and the quilters' room five times a month at Zion. The equipment and a supply of paper and cartons fill the closets. Besides St. Paul and Zion, Bethalto, crews from Trinity, Edwardsville; Hope, Highland; and Good Shepherd, Collinsville come once a month to produce books. Delores
